## Scholarships

### Public Sector SQE Scholarship

**Discount:**

**£600**

**Applies to:**

**All SQE1 Prep course options**

**Criteria:**

- Evidence of job offer or employed at a charity, not-for-profit or other public interest organisation
- Annual salary of less than £45,000
- Not applicable for those who have a firm or third-party paying tuition on the their behalf

### Essay Competition SQE Scholarship

**Discount:**

**One full fee scholarship; One half-fee scholarship; Eight £1,000 discounts**

**Applies to:**

**Focused 20-week SQE1 Prep and/or Accelerated 10-week SQE1 Prep**

**Criteria:**

Submit an original essay on the given topic of no more than 1,000 words (excluding references).

## BARBRI Humanitarian SQE Scholarship

**Discount:**

**50% off course fees**

**Applies to:**

**All SQE1 Prep course options**

**Criteria:**

Open to those who can prove asylum/refugee status or displacement due to war.

## Flexible Payment Plans

Several payment plans are available, including payments divided into monthly instalments designed to make paying for your course more manageable. You'll be required to pay the minimum £199 enrolment deposit and schedule the remaining balance (including the £149 finance fee).

If you take the Foundations in Law and SQE1 package, your payment plan will be adjusted accordingly.

### Example payment plan – pay £199 upfront plus:

Course	Payment Schedule	Cost per month
Flexible SQE1 Prep (40-week)	8 instalments	£693.62
Focused SQE1 Prep (20-week)	4 instalments	£737.25
Accelerated SQE1 Prep (10-week)	2 instalments	£1,474.50
